## CITATIONS: More details.

Scenario style papers are not required to, but may, have outside resources cited. However, you must cite information that came from class notes (term definitions, etc.). You should include the slide number in the in-line citation. I will allow the reference citation to be done as a website rather than a PowerPoint as a time-saving shortcut. Websites are cited as follows: APA. Generally, citing my slides in the reference section might look something like this:

When you introduce your scenario, you should not copy and paste it from the scenario slides. You should paraphrase the scenario and add plenty of your own interpretation/transition statements. You can even add new details in order to clarify some of the vague or missing information, or lend narrative elements to your paper to make it less boilerplate.

The scenario itself does not need to be cited even though it comes from an outside source.
